**SUMMARY OF TESTING METHODS AND KEY FINDINGS**

The real world testing demonstrates that Pegasus Quality platform is compliant with c(1), c(2) and c(3) (Cures Act) criteria against which it is currently certified. We did three rounds of testing as listed in Key milestones section.

The three rounds of testing demonstrated that:

1. Providers/Practices using Pegasus Quality platform in the production environment were able to generate QRDA1 and/or QRDA3 files for CMS measures relevant to the practice/provider (while testing we used CMS 130, CMS 122 and CMS 068, as these CMS measures are most widely used by our customers).
2. Providers/Practices were able to upload QRDA1 files and download QRDA1 and/or QRDA3 files by themselves.
3. FIGmd’s customers use the QRDA3 files for their annual CMS submissions.

We did not observe any non-conformities or challenges during the three rounds of testing.

We had sampled out some practices/providers who are using this primary care setting. The functionality of Pegasus Quality platform allowed the users to upload data in QRDA1 format and QRDA1 files were available for download, and users were able to generate QRDA 3 files and were able to download QRDA1 and QRDA3 files by themselves.

We did not observe any non-conformities.
